Prescription Shopping Information Service registration

When to use this form

Complete this form if you are a Health Professional who has been issued a prescriber number by Medicare and you wish to register for the Prescription Shopping Information Service (PSIS).

PSIS information

The information disclosed to a Health Professional under the PSIS does not include:

- samples
- private prescriptions
- over-the-counter medicine
- emergency treatment supply
- PBS medicine supplied by a pharmacist in an emergency
- medicine subsidised under the Repatriation Pharmaceutical Benefits Scheme (RPBS)
- Pharmaceutical Benefits Scheme (PBS) information about a patient who does not meet the programs criteria
- PBS Schedule Section 100 Medicine (including programs for Highly Specialised Drugs, Botulinum Toxin, Human Growth Hormone, IVF/GIFT, Opiate Dependence Treatment, Special Authority).

Conditions and limitations

- This registration applies to all provider numbers for the prescriber number nominated in question one of this form
- Under the PSIS, the Australian Government Department of Human Services is authorised to disclose to you specific information it holds about PBS medicine obtained by your patients, who meet the program criteria
- We cannot disclose any PBS information to you about a person unless that person is your patient
- Any information disclosed to you by us under the service may not represent a complete picture of your patient's medicine supply record
- Any information disclosed to you by us under the service is disclosed for the sole purpose of assisting you to make clinical decisions about the medicine needs of your patients, and must not be used for any other purpose
- We administer the Prescription Shopping Information Service within strict privacy and legal constraints.

Online secure transmission

An Individual Certificate will allow you to log onto our website to access your patient's PBS Patient Summary Report within minutes of making a phone call to the PSIS, while your patient is still with you. Reports are only available online if your patient meets the program's criteria.
